NOTICE OF TOLL EVASION

This Notice of Toll Evasion has been issued to collect tolls and penalties due. Our records indicate that the vehicle identified below drove the SB Express Lanes without paying a toll(s). All tolls on the SB Express Lanes are collected electronically from a pre-established FasTrak® account or online via our Pay Online payment option. Failure to make the proper toll payment violates California Vehicle Code (CVC) §§ 23302 and 23302.5, and SBCTA's Express Lanes Policy. Violations are subject to a civil penalty under CVC §§ 23302.5, 40250 and 40258, and SBCTA's Express Lanes Policy. Failure to pay all the toll(s) due by the specified date or otherwise respond to this notice will result in the penalties being reimposed and escalation of the penalty amount due and may result in attachment of the violation amount(s) to the registration of the vehicle listed (DMV registration hold); a civil judgment for the violation amounts, associated costs and interest; and other collection procedures as set forth in CVC § 40267 and/or California Government Code §§ 12419.10 and as allowed by law.
